- If H2SW is unable to preform the agreed services for any unforeseeable reason or unavoidable situation including any restrictions or concerns related to COVID19, or due to any circumstances beyond their control any and all deposits shall be returned to the client with the understanding that there will be no further liability with respect to this agreement.

Bride agrees that a final head count shall be given to the stylist no less than 90 days prior to the date of services if the count should change from this agreement. If the final headcount changes within the 90 day window of the date services are to be rendered the bride shall be responsible for payment and full service price shall be paid for services not changed prior to the 90 Day window. This includes additional persons added at the last minute and are at the discretion of the stylist. Bride agrees to provide any accessories/extensions to be used in the hair for styling. Bride also agree to having clean hair, free of product but not freshly washed or wet the day of the services for herself and all individuals receiving hair services. Any individual that requires hair to be dried in the event that their hair has been washed the morning of but not dried shall be subject to additional fee of \$25 to perform that service and deliver the style agreed upon as it cannot be done on wet hair. Bride is subject to travel fees and any costs associated with parking or tolls with said travel, these costs will be outlined below. In the unlikely and unfortunate event of the wedding being cancelled less than 90 days prior to the wedding date the bride assumes responsibility for 50% of the total services on the day of the wedding, if within 60 days than the bride will be responsible for 75% of the total service cost and within 30 days than 100% of the service cost will be charged. These will be charged to the credit card used to make your deposit. A 15% deposit shall be required to booked your wedding date along with a signed contract.

Entire Agreement

This agreement represents all terms and conditions agreed upon by both parties. No other understandings or representations, oral or otherwise, regarding the agreement shall bind any of the parties.

Payment is due in full at the time of service and is payable by Cash, Card or Venmo. Gratuity is not included or expected but always appreciated .
